

Heartworm Prevention Manufacturer Guarantee Requirements

Owner Acknowledgement Form

General Requirements for Coverage:

1. Negative heartworm test before starting any product if 4 months of age or older
2. Recheck heartworm test 4 months after starting a new product
3. Administered according to label directions
4. Heartworm test performed annually

Note: Please see additional requirements for each product and level guarantees listed below.

Products:

Proheart (Zoetis)

- Must be given by a certified veterinarian
- Guarantee
 - Up to \$500 towards heartworm treatment
 - 1 year supply of Proheart or \$100 towards 1 year's coverage by another heartworm prevention
- Additional Requirement: Must have at least 2 negative heartworm tests 6 months apart from the start of use

Advantage Multi (Bayer)

- Levels of guarantee

Level 1

- Additional Requirements:
 - Starting prevention at 7 weeks to 4 months of age: covered without prior heartworm test
 - Starting prevention at 4-6 months of age: negative heartworm test 4 months after starting use
 - Starting prevention at 6 months of age and older: at least 12 months of consecutive doses with test prior to starting product and retest 4 months later
 - Positive heartworm test must be confirmed with an independent lab
- Guarantee Coverage: \$1000 for veterinary services for treatment

Level 2

- Additional Requirements: Minimum of 6 consecutive doses
- Guarantee Coverage: \$500 towards veterinary services for treatment

Trifexis (Elanco)

- Additional Requirements:
 - Starting prevention at puppy to 4 months of age: must have continuous coverage
 - Starting prevention at 5 months and older: test 6 months later with continuous purchases
- Guarantee:
 - Up to \$800 towards heartworm treatment per pet up to 4 pets per household
 - Will cover same pet more than once in a lifetime

Heartgard (Merial)

- Will cover once per lifetime of a dog
- Levels of guarantee

Level 1

- Additional Requirements
 - At least 9 months of continuous purchase
 - Starting prevention at 6 weeks to 4 months of age: covered immediately
 - Starting prevention at 4-6 months of age: covered following a negative heartworm test 6 months after 1st dose
 - Starting prevention at 6 months and older: covered if heartworm test is done prior to 1st dose and a retest 6 months following to prove negative
- Guarantee Coverage
 - \$500 for veterinary services
 - Complimentary immiticide
 - 1 year of Heartgard

Level 2

- Additional Requirements
 - At least 9 months of continuous purchase but with missed doses
- Guarantee Coverage
 - Complimentary immiticide
 - 1 year of Heartgard
